## **Admissions Requirements for Concurrent Students:**

- Application
- Official High School Transcripts
- Official ACT Scores
- Approval from Guidance Counselor

### **Course Load:**

A high school student may enroll in a combined number of high school and colleges per semester hour not to exceed a full time college workload of 19 semester credit hours. For purposes of calculating workload, one-half high school unit shall be equivalent to three semester credit hours of college work.

### **Continued Enrollment:**

To continue concurrent enrollment in the following semester, high school students must maintain a CGPA of 2.0 or above on a 4.0 scale.

### **Upon High School Completion:**

Once the student has graduated and has decided to continue in pursuing a degree from Mid-America Christian University the student will need to go through the admissions process for full-time students.
