Admissions Requirements for Concurrent Students:	
□ Application □ Official High School Transcripts □ Official ACT Scores	
 □ Approval from Guidance Counselor □ State/Local Government-Issued Identification (Front and Back) 	
Course Load: A high school student may enroll in a combined number of high school and colleges per semester hour not to exceed a full time college workload of 19 semester credit hours. For purposes of calculating workload, one-half high school unit shall be equivalent to three semester credit hours of college work.	
Continued Enrollment: To continue concurrent enrollment in the following semester, high school students must maintain a CGPA of 2.0 or above on a 4.0 scale.	
<u>Upon High School Completion:</u> Once the student has graduated and has decided to continue in pursing a degree from Mid-America Christian University the student will need to go through the admissions process for full-time students.
